Please complete the application indicating the reason you are unable to attend the ***Library's Annual Budget Vote*** taking place on Tuesday, September 26, 2017.

Once complete, you can receive your ballot by either mailing the application back or bringing it to the Main Library.

If you wish to have a ballot mailed to you we need to receive your application no later than Tuesday, September 19<sup>th</sup>.

If you wish to pick up the absentee ballot **personally** (bring ID), you may return the application as late as 7:00 pm on Wednesday, September 20<sup>th</sup>. **You may not pick up an absentee ballot for another person.**
